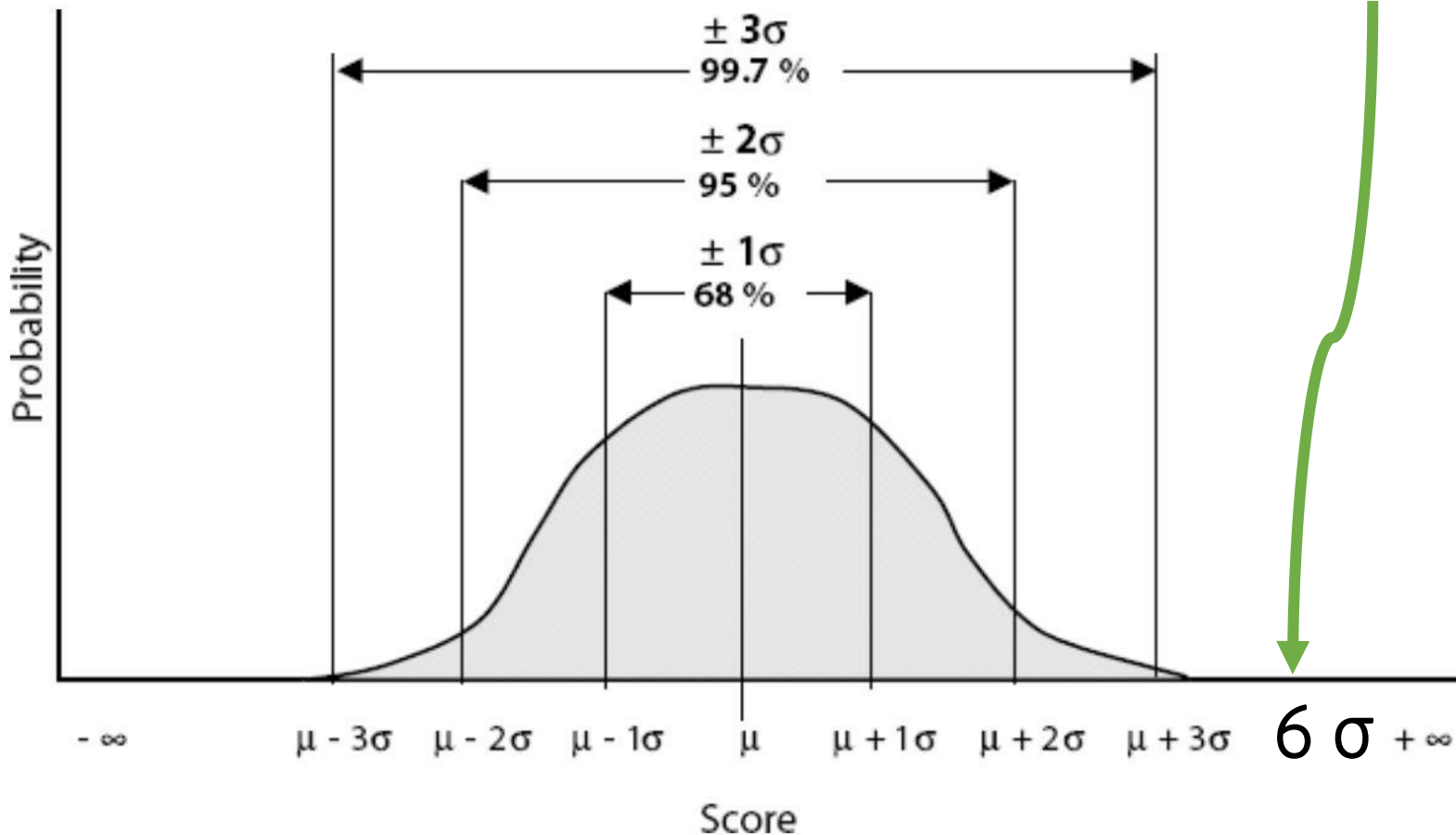

SIX SIGMA level, which essentially means 3.4 defects for every one million opportunities

RISK PERCEPTION



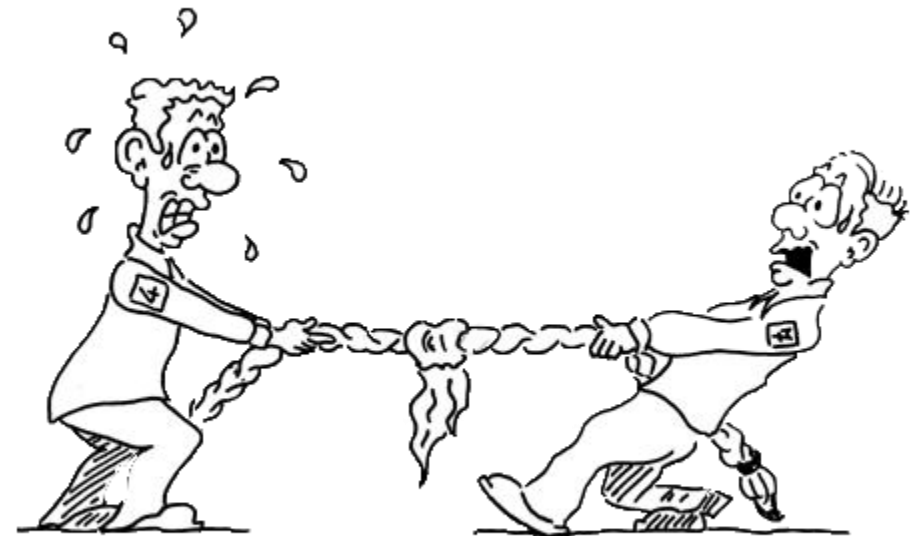
What do you see here? Two animals or just a green tree?

Any offer that looks “too good to be true” usually turns out to be a scam or maybe a spam in your mailbox.



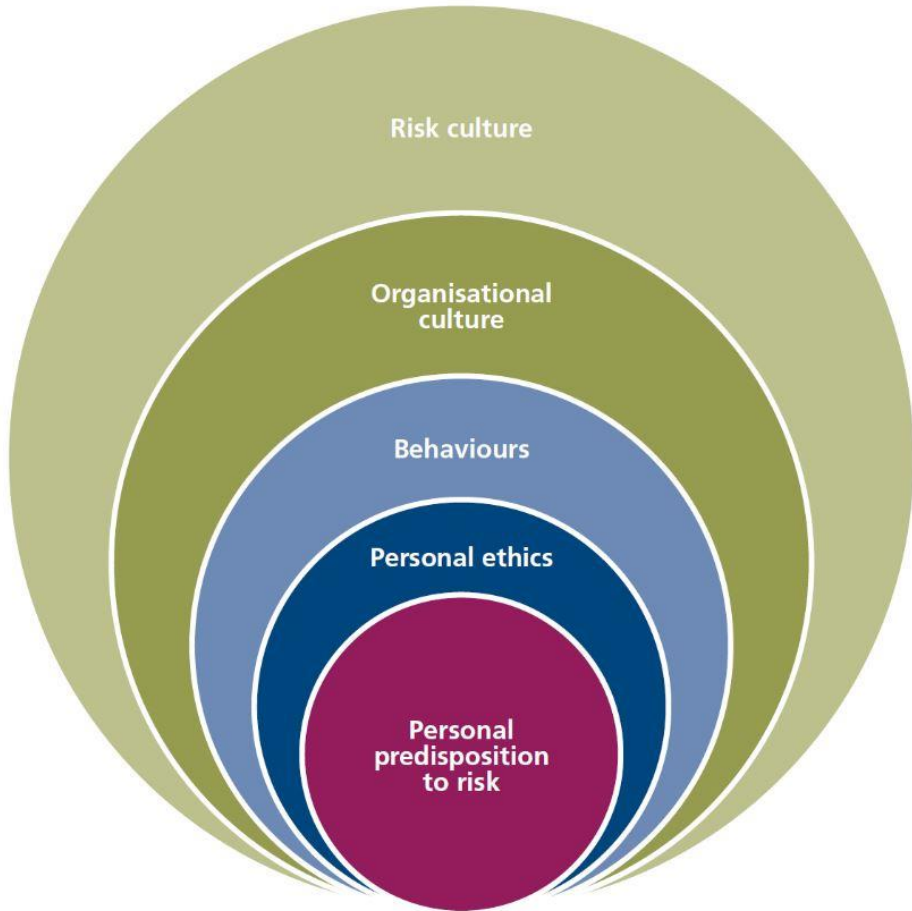
Risk Management is not just about minimizing exposure to **wrong risks**, but it is an effort to increase exposure to **good risks!**

Steps to change your risk culture

Evaluate the current risk culture

- Look for hidden and sub cultures
- Use several techniques to surface all cultures

Cultural change requires a sustained effort as the culture needs time to adapt new norms.

What is the impact of the current culture?

- What are its strengths and weaknesses?
- Is this the right culture for our future?

How easily can we adapt this culture change approach to international situations?

What would improve our risk culture?

- Are there regulatory or other external drivers to consider?
- What changes do we have to make?

Continuous review is essential

Plan and implement our cultural change

- What do we need in place to grow and sustain our new risk culture?
- What changes do we have to make?

Monitor and adapt to changes

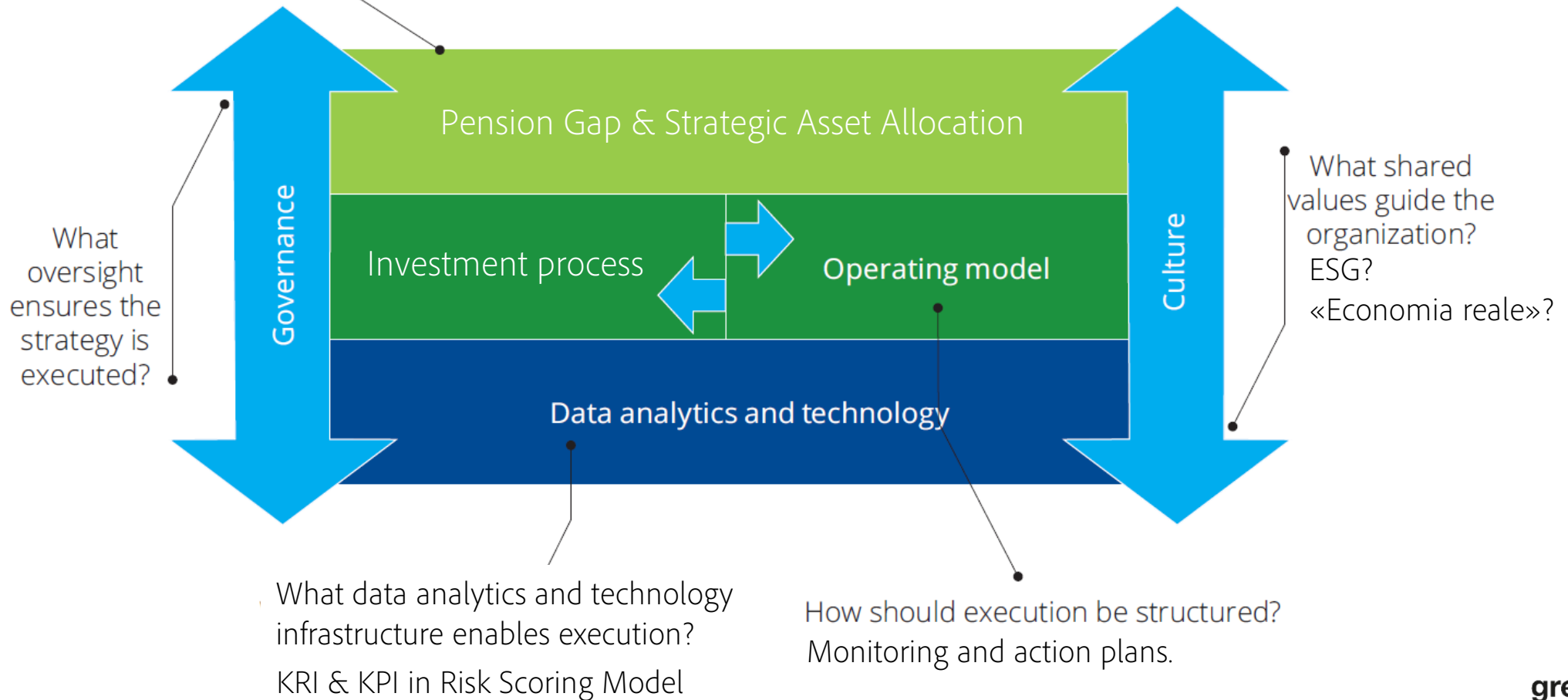
- Are we achieving the outcomes we expect?

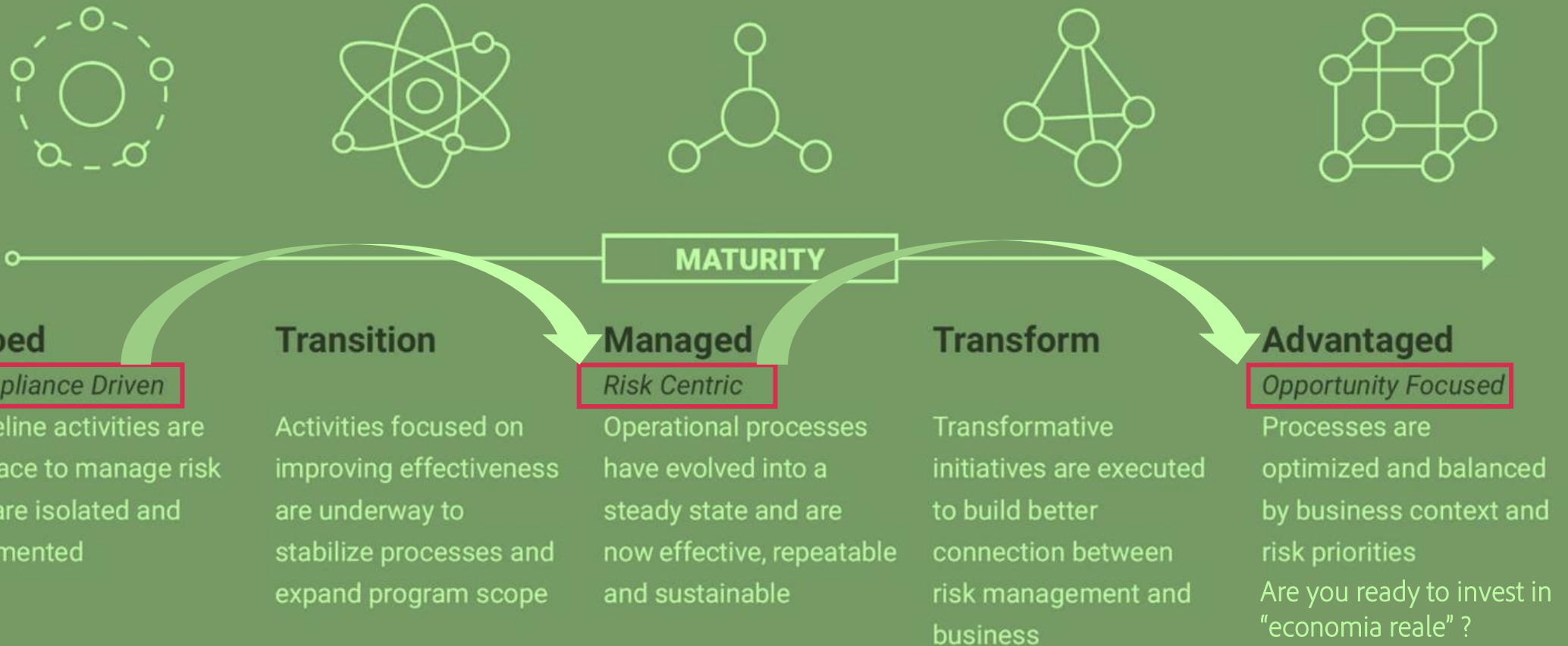
Population distribution and definition of the investment period and performance target

EVOLUTION ON RISK MANAGEMENT





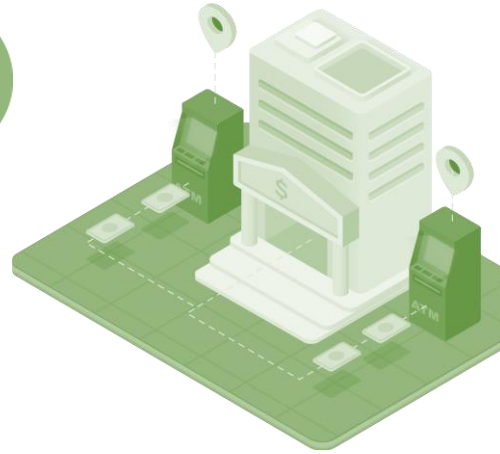
POTENTIAL CROSS FERTILIZATION



The insurance industry has traditionally focused on **operational risks** and extreme event risks. Typically the risk factors are not observable nor traded in the market. It requires specific capabilities to estimate the risks.



Banks are always aware of the **credit risk** of their borrowers. The estimation of the default probability follows strong statistical methodologies.



A **strong Risk Management system** requires full competence of data science methodologies as well as a deep understanding of one's own business such as investment activity in Pension Funds. The interactions with other participants allow to achieve 360° skills.



CHIEF RISK OFFICER 2.0



INTEGRATION

Increasing interdependencies between economies (and business). Larger impact of risk events than in the past (also higher frequency).



CULTURE

Mature institutional investors are those who have a wide diffusion of the risk culture on all processes. All stakeholders are risk managers!



INVOLVEMENT

It is necessary to achieve a strong integration of risk management at the board level to correctly evaluate strategies and risk assumption.



COMPETENCIES

Managing risk today requires specific skills and a full understanding of financial products in relation to return expectations.

3 POLICY IMPLICATIONS

1. Grow up the educational level required from Investors with some Risk Management Certification (FRM GARP or PRMIA)
2. Promote best practices such as Board induction sessions for new board members
3. Promote merge between similar Pension Funds regarding population and income distribution

RISK MGMT AS VALUE CREATION PROCESS



Risk Management could be viewed as a **value-creating activity**, and not just as a mitigation activity!

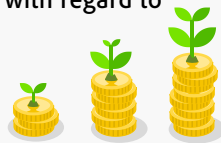
TRANSPARENCY RISK

The main element of a successful governance model is given by the degree of transparency and reproducibility of the results obtained (e.g. benchmark).



REPUTATIONAL RISK

The management of public savings requires safeguarding against potential reputational risks also with regard to suppliers / advisors.
