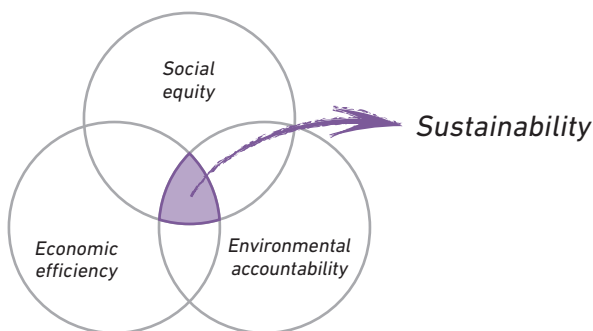


WHAT IS BUSINESS SUSTAINABILITY?

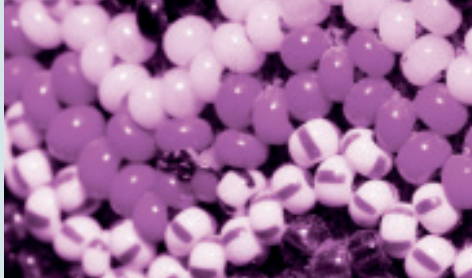

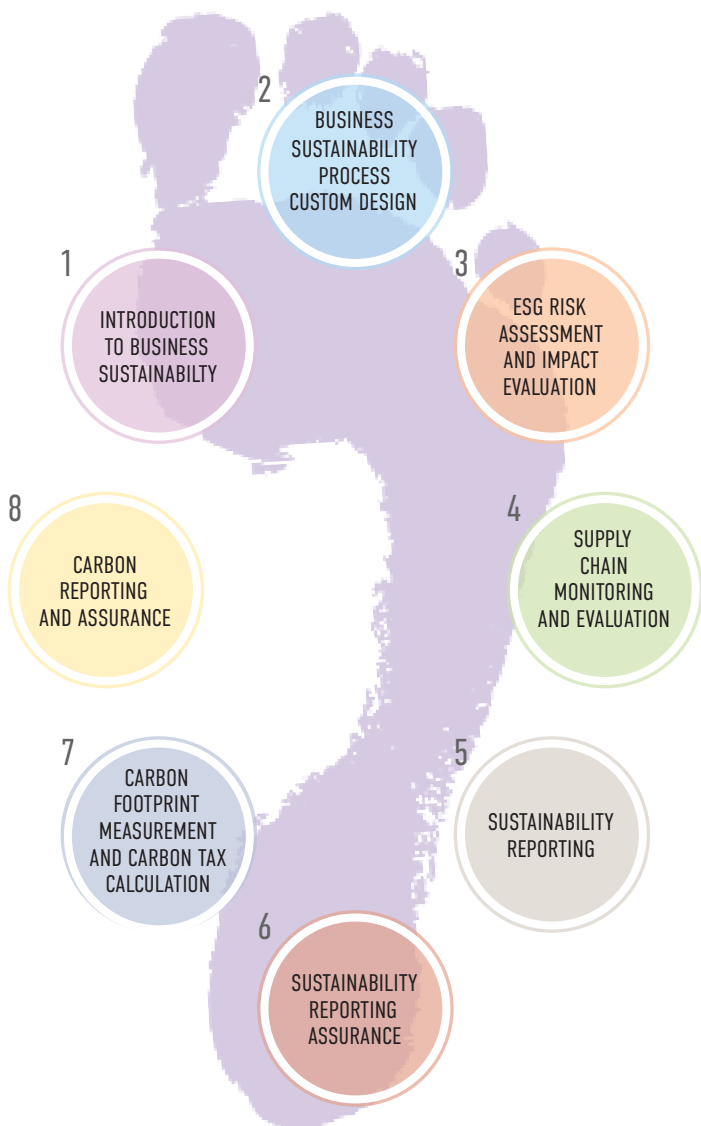

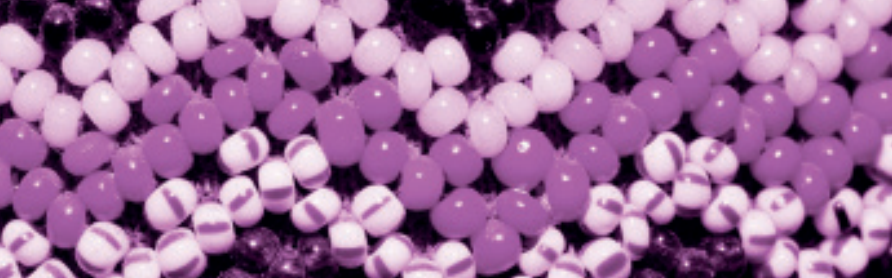
